## ENVIRONMENT, HEALTH AND SAFETY POLICY

### Policy Statement

**Giriraj Civil Developers Limited (the “Company”)**, a leading civil infrastructure developer in Railway Sector, is committed to **continual improvement in Environment, Health and Safety (EHS) performance**. We believe that safeguarding people, property, and the environment is fundamental to sustainable growth and operational excellence.

Our EHS policy ensures responsible and ethical business conduct by focusing on:

- Protecting occupational health and safety of employees, contractors, and stakeholders,
- Preventing and controlling workplace hazards and infectious diseases proactively,
- Complying with all statutory, regulatory, and contractual requirements,
- Embedding EHS practices into daily operations across all projects and sites.

### EHS Objectives

The Company shall pursue the following objectives:

- **Environmental Protection:** Reduce environmental degradation, promote the 3Rs (Reduce, Reuse, Recycle), and optimize resource use to prevent pollution and safeguard ecosystems.
- **Occupational Health Care:** Promote employee health and well-being through continuous risk minimization and preventive healthcare initiatives.
- **Zero Harm Goal:** Strive for continual reduction of Lost Time Injury (LTI) frequency rate and achieve the long-term goal of zero incidents.
- **Sustainable Practices:** Integrate sustainability into construction and infrastructure development activities.

### EHS Principles

The employees, contractors and stakeholders are expected to comply with the EHS Policy requirements of the Company and achieve objectives by following these principles:

- **EHS is Non-Negotiable** – Compliance with EHS requirements is a mandatory condition of employment and engagement. Every individual must work towards preventing injuries, ill health, pollution, wastage, and environmental damage.
- **“EHS Starts with Me”** – Each employee is personally responsible for EHS and must propagate this culture within their teams, becoming EHS Ambassadors.

- **Competency through Training** – Employees and contractors must undergo regular EHS training to build competency and awareness. Leaders are responsible for ensuring their teams are trained and supported.
- **Safe Work Practices** – Every employee must proactively stop unsafe work and refuse to perform activities where EHS requirements are not met. Work must be completed in a safe and responsible manner.

- **Employee Responsibility:** All employees are accountable for adhering to EHS standards and reporting unsafe conditions.
- **Contractor Compliance:** Contractors and suppliers must align with this policy and demonstrate EHS compliance in their operations.
